However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement, in the possession of the funeral establishment, that has been signed and paid for, in full or in part, by or on behalf of the decedent.

**Payment Terms**

*Payment is due in full prior to services being rendered. We accept VISA, Mastercard, Amex or Discover.*

**In compliance with the Federal Trade Commission, we offer the following prices:**

**Direct Cremation (A2A Simple Cremation) \$995**

*Includes the basic services of a funeral director and staff, the removal of the decedent from a hospital or coroner’s office, sheltering the decedent in our climate-controlled area, alternative cremation container, transport to crematory, crematory fee, completion of the death certificate, disposition permit fee, Department of Consumer Affairs fee and a temporary container. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.*

- (additional) Removal of implanted mechanical device \$125
- (additional) Removal from a private residence \$300
- Direct cremation w/ container provided by purchaser \$895

**Basic Services \$500**

*Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs This fee for our basic services and overhead will be added to the*

*total cost of the cremation arrangements you select. (This fee is already included in our charges for direct cremation.)*
