If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement, in the possession of the funeral establishment, that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Our personal service to you also includes Veteran's benefits, social security assistance, letters of verifications to employers and airlines. We also arrange for the procurement of certified death certificates, both local and out-of-area, and other special services to your family.

### ***Payment Terms***

Payment is due in full prior to services being rendered. We accept VISA, Mastercard, Amex or Discover.

### ***Direct Cremation ..... \$995***

The cremation package listed below does not include weekend/holiday fees, additional hours, additional staff, residential removals, sales tax, or any other add-on you may require.

- Transportation of Remains from Hospital, Nursing Home, or Coroner's Office
- Sheltering the Decedent in our Climate-Controlled Area
- Alternative Cremation Container

***Itemized Prices***

***Basic Services..... \$500***

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs This fee for our basic services and overhead will be added to the total cost of the cremation arrangements you select. (This fee is already included in our charges for direct cremation, hydrolysis and burial packages).

***Embalming..... \$650***

This also includes the dressing and cosmetics for your loved one.

**Embalming is not required by law and does not halt decomposition. We do not require embalming for viewings under 2 hours.**

***Refrigeration ..... \$150***

For up to 5 days

After 5 days ..... \$60/day

***International Shipping Administrative Fee..... \$400***

Includes charges levied by consulate and/or other government agencies required to ship remains internationally.

***Use of Facilities & Staff for Viewing/Memorial/ Vigil..... \$500***

***Addition Hour after 1 Hour..... \$150/hr***

A one hour self-lead service in the Fireside Room of Throop Unitarian Universalist Church for up to 20 people. Includes dressing or draping of clothing, making your loved one presentable, and transportation.

***Use of Equipment & Staff for a Service at Another Location..... \$500***

Includes casketing, dressing or draping of clothing, making your loved one presentable, transportation, the use of any equipment, and two staff members.

***Additional Charge for a Saturday or Evening Service..... \$450***

Any service scheduled on a Saturday or after 4:00PM (No Sunday Services)

***Cremation ..... \$400***

This charge does not include any other service than the cremation itself.
